

of the family. He also has a new sister, Reese, who is very sweet with him. Monty now has the cutest little collar with a bell and a tag that says, "Please call my mom. I am blind." Just made my heart swell to see that. She is the perfect mom for him because she supports him in being his absolute best. He is exploring his environment, has discovered how to locate his water bowl, is making use of a scratching post...all the normal, everyday things that cats do but,

### VCCA Chairs Corner

#### Vermont Commons TNR Program

The objective of our Trap-Neuter-Release (TNR) program is to help stabilize and then reduce the population of free-roaming cats in our neighborhood. We'd like to give you an update on the cumulative results since the program was formed in 2012.

We have received a total of \$ 2,565 in donations from our neighbors. We have spent \$ 1,394 at Spay Neuter Assistance Program (SNAP) and \$300 at the Cat Vet Clinic when the oppressive heat dictated the need to hospitalize kittens for their spay/neuter surgeries. We have a balance of \$871.

With your donations, we have spay/neutered 21 cats and kittens. Most of these cats were returned to the place they were trapped, but some were found to be tame and were placed in loving homes.

Our neighbors have also paid out of their own pockets for an estimated additional 30 cats and kittens to be spay/neutered. Many of those were placed in loving homes. One injured feral cat was trapped by a caring neighbor but had to be euthanized.

Now comes the astonishing number. These surgeries have prevented an estimated 1020 animal births!

I think we can all agree that we are happy to have over one thousand fewer cats in the neighborhood.

Reducing Vermont Commons' free roaming cat population is an ongoing multi-pronged effort. Preventing kitten births through our spay/neuter program of free roaming cats is paramount. However taming wild kittens, re-homing tame cats and keeping owned cats inside are all critical to our success.

If you have unaltered cats/kittens around your house or a neighbor's house, they need to be spayed/neutered. You can identify a cat/kitten that has already been spayed/neutered by looking at its ears. A spayed/neutered cat will have the tip of its left ear clipped off.

## The Harris County Constable Patrol Program:

With the goal of increasing safety, security, and quality of life in our neighborhood, several Vermont Commons residents have formed a committee to investigate the potential for a Harris County Constable Patrol in Vermont Commons.

We are holding an educational meeting for all Vermont Commons residents on **Tuesday, October 27<sup>th</sup>, 6:30 p.m., at Café Ginger**. Harris County Precinct 1 Constable Alan Rosen will discuss how the program works, its benefits to participating neighborhoods, program costs, as well as answer any questions.

To provide firsthand perspective on the program, Michael Hawash, organizer of the Constable Patrol program in Mandell and Winlow Place, neighborhoods directly to the south of Vermont Commons, will be on hand to describe their experiences, offer suggestions, and discuss the possibility of Vermont Commons partnering with these adjacent neighborhoods.

## Blue and White Tiles: Street Name Mosaics

Have you noticed the blue and white tiles forming street name mosaics on the

and trucks, re-paving, re-curb-ing, name changes



and destruction for handicapped access at corners have all taken their toll on this pleasant reminder of Houston's slower paced past. There is a tile mosaic at the intersection of Hazard and Welch. Hopefully, the builder at that intersection will not damage or remove it.

curbs at the street intersections in Vermont Commons? The tiles were laid in the 1920s and 1930s by the City of Houston when the area streets were paved and curbs were added. It was cheap, attractive, durable, and easy to read. The use of the tiles was discontinued when the city felt that the names on the curbs could not easily be seen. The tiles were replaced with street names on concrete posts. Drivers were going faster and found that street signs on poles were easier to read at the higher speeds.



If a contractor, no matter if it is city or private, is working on the curb where the tiles are present, a resident can ask that they not be removed or that the tile

Today, while a number of these relics remain in pristine condition, most are in various states of deterioration. Age, contact with automobiles

be placed onto the new curb.

The city does not protect the tiles, but contractors have been co-operative at leaving them in place. Historically and esthetically, it would be great if all the remaining tiles were protected. 


