They say they need access to your back yard to work on a neighbor's fence or trim a neighbor's tree or carry out another other work that you have not requested.

You come out your front door to walk them around the side to your back yard. Or you let them walk through your house to get there. But you didn't lock the front door or



the back door during these distracting actions.

Now you're in the back yard with one of the men, looking at broken fencing or overgrown trees. Where's the other man?

He may have slipped inside your residence, where he's taking your jewelry and other valuables before high-tailing it down the street. Then his partner in crime tells you he needs to get drive around to the next block to look at the work assignment from the other side.

But you never see them again. You've been fleeced, flim-flammed and tricked out of your very precious items.

Unfortunately, this story has played out a few times time recently at single-family homes in Precinct 1. There's very little information about what they look like.
