# **Residential Fence Rules and Guidelines**

Did you know? The City of Houston requires a permit if you construct a concrete or masonry fence, or if your fence will be over 8 feet high.

Specific Rules and Restrictions

• *Front Yard Fences* – Fences in front yards must get approval from the Houston Planning and Development Department. They may not be allowed in HOA controlled developments.

• Side Yard Fences – Required setbacks may apply, with height restrictions.

• Back Yard Fences – 8 feet maximum height without permit.

• *Corner Lot Restrictions* – Observe setback limitations. Fifteen feet line of sight triangles are required at intersections. Front yard fence prohibitions may also apply in HOA controlled areas.

• *Prohibited along Sidewalks* - Except as otherwise provided, it shall be unlawful for any person to erect or maintain, within the city limits, any railing or fencing along the sidewalks or next to the street. This applies to both residential and commercial property.

• *Residential Swimming Pools* - In Houston, areas with swimming pools must be enclosed by a fence. Houston's Health and Safety Code stipulates a fence's requirements, which include at least 48 inches in height. Furthermore, if it is not a privacy fence, an opening in the structure may not be wide enough to permit a 4-inch "sphere," or ball, from passing through it, unless the fence is made out of chain-link material. In this case, the links must be tight enough that a sphere no larger than 2 inches can pass through. Any gates must be latched and lockable.

Before you erect or replace a fence on your property, know these rules. If you see improper fence construction, approach your neighbor and/or call 311. Maintaining city code within Vermont Commons will help to preserve the neighborhood esthetics.
