TREES TREES TREES

The Tree Committee activity has picked up, starting with the VCCA Board approving \$5,000 in funding in 2024 for tree planting in VCCA! We are hoping this is the start of an annual activity that results in the "ever-greening" of Vermont Commons streets. Over the coming months, the committee will be providing details on how residents can participate this year, which would qualify them for a subsidy. The committee is also finalizing data on the best types of trees to plant in VC, best practices for tree planting, preservation and maintenance, and having discussions with several contractors regarding the project. More details to follow the next couple months!

In the April newsletter, we promised more information regarding City of Houston ordinances for preservation of trees. The COH Permitting Center (www.houstonpermittingcenter.org/prd1001) states in part that:

"A permit is required to remove any tree on city property (which include trees planted on rights of way, medians, parks and other city property) or on a setback."

In addition, COH Tree and Shrub Ordinance, Landscape Regulations for Development protects certain trees from removal including trees in the Right-of-Way, Corridors, Green Corridors, designated trees and Parkway trees. Property owners who unnecessarily destroy a protected tree can be fined and violations of the Tree & Shrub Ordinance carry a potential fine of up to \$500 per day for each violation.

If you witness activities that could lead to the removal of trees in the areas noted above, please call the Urban Park Rangers dispatch at 832-395-7100 so the department can check for permits and avoid unnecessary street tree loss. This phone line is answered 24 hours a day. Once the tree is removed, it's too late!

Last, but not least, we are heading into the hotter seasons, so please make sure you water your trees regularly if we aren't getting rain. "Watering Rings" are available at many locations or online and are a good option to conserve water through a slow release.
